ABOUT THE EVENT

The Tri-Partite Partnership (TPP) between the United Nations Development Programme (UNDP), the United Nations Office of the High Commissioner for Human Rights (OHCHR), and the Global Alliance for National Human Rights Institutions (GANHRI) is holding its Annual Review Meeting on 24-25 June, 2020. By promoting an exchange of information, knowledge, good practices, challenges and crystallizing capacity needs through a virtual dialogue, the TPP partners and broader stakeholders in the UN system will be able to set joint and complementary priorities for engagement and support in the coming period. The meeting offers an opportunity for NHRIs to directly interact with the UN system, be apprised of key developments in the UN in relation to their work and provide important country, regional and global level experiences and knowledge to UN partners from across the system to further inform how they can orient their future engagement and support.

- · Human Rights and the SDGs are mutually reinforcing and complementary. Over 90% of the goals and targets of the SDGs correspond to human rights obligations. [https://www.humanrights.dk/sdg-human-rights-data-explorer.]
- As of 4 March 2019, there are 78 NHRIs accredited with A Status by the GANHRI, i.e. in compliance with the Paris Principles.

- More countries are establishing legal and institutional frameworks for the defense of human rights, but the pace of progress is slow. Despite their importance, only 39% of Member States have an NHRI that has been reviewed for compliance with internationally agreed standards (the Paris Principles) in 2018. - Murder rates among human rights defenders, journalists and trade unionists are rising.
